

Durkheim, in his very role as a 'founding father' of a new social science, sociology, has become like a figure in an old religious painting, enshrouded in myth and encrusted in layers of thick, impenetrable varnish. This book undertakes detailed, up-to-date investigations of Durkheim's work in an effort to restore its freshness and reveal it as originally created. These investigations explore his particular ideas, within an overall narrative of his initial problematic search for solidarity, how it became a quest for the sacred and how, at the end of his life, he embarked on a project for a new great work on ethics. A theme running through this is his concern with a modern world in crisis and his hope in social and moral reform. Accordingly, the book concludes with a set of essays on modern times and on a crisis that Durkheim thought would pass but which now seems here to stay.



2 A Matter of Trustindia: Us Relations From Truman to Trump/ Ahamed, Meenakshi-HarperCollins, New Delhi, 2021; 562p. 54275

From Truman's remark to now, it has been a long journey. India and the US, which share common values and should have been friends, found themselves caught in a dysfunctional cycle of resentment and mistrust for the first few decades following Indian independence. In A Matter of Trust, author Meenakshi Ahamed reveals the personal prejudices and insecurities of the leaders, and the political imperatives, that so often cast a shadow over their relationship. The cycle began with India's first prime minister, Jawaharlal Nehru, who viewed Americans as naive and insular, but it was under Indira Gandhi that India entered the darkest phase of its relations with the US. President Truman decided Nehru was a communist, and the White House tapes reveal Nixon's hatred towards Mrs Gandhi and Indians. It was only after India undertook major economic reforms in the 1990s that the relationship improved. The transformation occurred when President George W. Bush signed the historic nuclear deal in 2008 with Prime Minister Manmohan Singh. Meenakshi Ahamed draws on a unique trove of presidential papers, newly declassified documents, memoirs and interviews with officials directly involved in events on both sides to put together this illuminating account of their relationship that has far-reaching implications for the changing global political landscape.



3 A Sociolinguistic History of British English Lexicography/ Yong, Heming-Routledge, London, 2022; 262p.

A Sociolinguistic History of British English Lexicography traces the evolution of British English dictionaries from their earliest roots to the end of the 20th century by adopting both sociolinguistic and lexicographical perspectives. It attempts to break out of the limits of the dictionary-ontology paradigm and set British English dictionary-making and research against a broader background of socio-cultural observations, thus relating the development of English lexicography to changes in English accomplishments in English linguistics, social and cultural progress, as well as advances in science and technology. It unfolds a vivid, coherent and complete picture of how English dictionary making develops from its archetype to the prescriptive, the historical, the descriptive and finally to the cognitive model, how it interrelates to the course of the development of a nation's culture and the historical growth of its lexicographical culture, and how English lexicography spreads from British English to other major regional varieties through inheritance, innovation and self-perfection. This volume will be of interest to students and academics of English Lexicography, English Linguistics and world English lexicography.

4 Beyond Anthropology to Post-anthropology towards a New Theory of Centrality and Peripherality in the Post-human Future (2 Volumes)./ Baofu, Peter- Overseas Press India, New Delhi, 2017; xxxiii, 799p. 54276-54277

Is anthropology really so heterothallic that, as Ruth Benedict once suggested, "the purpose of anthropology is to make the world safe for human differences" (BQ 2017) This positive view on anthropology can be contrasted with the opposing one by Nancy B. Smith, who observed instead that "anthropology is the science which tells us that people are the same the whole world over-except when they are different"? (BQ 2017a) Contrary to these opposing views (and other ones as will be discussed in the book), anthropology (in relation to centrality and peripherality—as well as other dichotomies) is neither possible (or impossible) nor desirable (or undesirable) to the extent that the respective ideologues (on different sides) would like us to believe, such that there is no centrality without peripherality (and vice versa), to be explained by the "symmetryasymmetry principle" (and other ones) in "existential dialectics" (in Chapter Four). Needless to say, this challenge to the conventional debate does not mean that anthropology is worthless, or that those diverse fields (related to anthropology)—such as sociology, cultural studies, religion, criminology, jurisprudence, medicine, science studies, biology, linguistics, philosophy, economics, political science, cosmology, psychology, social studies, history, literature, ecology, the arts, communication studies, technology studies, and so on-should be rejected. (WK 2017) Of course, neither of these extreme views is reasonable.



5 Beyond Human Civil Society to Post-human Civil Society 2 Vol Set/Baofu, Peter- Overseas press, New Delhi, 2018; 907p. 54281-54282


Is human civil society really so promising that, as Edmund Burke once claimed, "Justice is itself the great standing policy of civil society, and any eminent departure from it, under any circumstances, lies under the suspicion of being no policy at all?? (TE 2018) This positive view on human civil society can be contrasted with an opposing one by Geoff Mulgan, who cautioned us by asking: "So is civil society prepared for the future? Probably not. Most organisations have to live hand to mouth, juggling short-term funding and perpetual minor crises. Even the bigger ones rarely get much time to stand back and look at the bigger picture. Many are on a treadmill chasing after contracts and new funding." (BQ 2018) Contrary to these opposing views (and other ones as will be discussed in the book), human civil society (in relation to civilness and non-civilness—as well as other dichotomies) is neither possible (or impossible) nor desirable (or undesirable) to the extent that the respective ideologues (on different sides) would like us to believe, such that there is no civilness without non-civilness (and vice versa), to be explained by the "softness-hardness principle," the "materiality nonmateriality principle," the "achievement-carefreedom principle," the "inclusiveness exclusiveness principle," the "symmetryasymmetry principle," the "valuation-devaluation principle," the "absoluteness-relativeness regression-progression principle." the principle.



6 Beyond Human Political Behavior to Post-human Political Behavior (2. Volume Set)/ Baofu, Peter- Overseas press, New Delhi, 2017; 320p

Book Abstract Is political behavior really so significant that, as Aristotle wrote, "man is by nature a political animal"? This positive view on human political behavior can be contrasted with the opposing one by Will Vittery (2010), who critically rebuked that "this is a mistaken take on what is acute naturalacute; to a human being. It suggests that simply by living in society is a political act, and argues that society is in itself natural—that man is almost biologically pre-determined to live in societies. Living in society does not necessarily make man political, it merely puts them in a political situation. Rather, society itself is completely man-made.... Contrary to these opposing views (and other ones as will be discussed in the book), human political behavior (in relation to enthusiasm and apathyas well as other dichotomies) is neither possible (or impossible) nor desirable (or undesirable) to the extent that the respective ideologues (on different sides) would like us to believe, such that there is no enthusiasm without apathy (and vice versa), to be explained by the "enthusiasm-apathy principle" (and other ones) in "existential dialectics" (in Chapter Four). As a reminder, this challenge to the conventional debate does not mean that political behavior, as a field of study, is useless, or that those diverse fields (related to human political behavior)-such as sociology, economics, political science, anthropology, history, philosophy, literary theory, religion, psychology, biology, and so on-should be rejected. (WK 2017) Needless to say, neither of these extreme views is reasonable.



7 Bharthari: A Chhattisgarhi Oral Epic/ Tiwari, Nandkishore- Sahityah Akadmi, Delhi, 2022; 156 p.

Indian languages carry within them a rich heritage of creativity which has been transmitted from generation to generation entirely in oral forms. Among the languages that are presently spoken in India, a relatively small number of languages have been put down in scripts. As against these scripted languages, for which a special schedule is devoted in India's Constitution, there are those other languages which are living and used in daily life but not codified in systems of orthographic representation. Most of these other languages are spoken by India's vast and varied tribal population, spread over nearly eighteen states. In order to document and preserve the rich tradition of oral literature in the tribal languages, Sahitya Akademi has established the Tribal Literature and Oral Tradition Project. Under this project a series of bilingual literary texts is being published. So far the volumes in Bhilli, Dehwali, Garhwali, Varli, Kunkna, etc. have been published, and other volumes in Mizo, Garo, Khasi, Bodo, Santhali, etc. will shortly be published. The present volume, Bharthari, which brings together the Chhattisgarhi version of a heroic-spiritual legend and its simple English rendering, is a result of painstaking documentation and research by Dr. Nandkishore Tiwari. A version of this saga with its Hindi translation was brought out earlier (1994) by the Madhya Pradesh Adiyasi Loka-Kala Parishad. The English translation in this volume is mainly by Dr. H. U. Khan and is reworked by Dr. Arvind Macwan.



8 Capitalism and Its Critics: Capitalism in Social and Political Theory/ Delanty, Gerard-Routledge, New York, 2023; 220p. 54285

Capitalism and its Critics offers an accessible account of major theories of capitalism from the industrial revolution to the present day. The book provides a comprehensive account of the economic and social thought of key theorists from Adam Smith and Karl Marx to David Harvey and Thomas Piketty. Capitalism has long been the subject of passionate debate. and today such contestations are perhaps more timely than ever. For its advocates, capitalism brings democracy and freedom and is the cornerstone of modernity and of progress. For its critics, capitalism is based on the exploitation of labour and is responsible for the destruction of the environment as well as colonialism. Whether capitalism survives the century, or whether an alternative social system emerges, may very well determine the fate of humanity. Capitalism and its Critics gives a comprehensive critical analysis of the most important theorists of capitalism, including Adam Smith, Karl Marx, Max Weber, Joseph Schumpeter, Karl Polanyi, F.A. Hayek, J.M. Keynes, David Harvey, and Thomas Piketty. The book discusses some of the main debates about capitalism and considers alternatives in the twenty-first century. The twelve chapters are loosely chronologically organised around the main approaches and historical phases in the history of capitalism. Central themes of the book are the ideas of capitalist crisis and of tensions between democracy and capitalism in the making of modernity. A highly readable, informative and engaging text. Capitalism and its Critics is essential reading for anyone interested in understanding capitalism and its alternatives.



9 Childlessness in Bangladesh: Intersectionality, Suffering and Resilience/ Nahar, Papreen-Routledge, New York, 2022; 228p.

This book examines the various dimensions of infertility in the context of Bangladesh, based on ethnographic research conducted on the embodied experience of rural and urban women. Childless women in Bangladesh, an over-populated country where fertility control is the primary focus of health policy, are all but non-existent. Papreen Nahar offers an alarming account of stigma, abuse, ostracism and violence against these women, sharing their experiences of marginalisation in a culture that idealises motherhood. In such a reality, the experience of childlessness, particularly for women, can be much more severe than what is defined as 'infertility' in the biomedical sense. As childlessness is a complex interaction between biology, society and culture, the book illustrates the ways in which infertility transforms a health problem into social suffering. Although Bangladeshi childless women are systematically excluded by various structural forces, it appears they do not succumb to their circumstances; rather, they develop resilience and agency to become survivors of their new, albeit bleak, lives. The volume will be of interest to scholars working in anthropology. reproductive and women's health, global health, gender studies, development studies and Asian studies.

Civil Society Revisited: Lessons From Poland (Studies on Civil Society, 9)/
 Jacobsson, Kerstin-Berghahn Books, New York, 2017; 352p.

In much social scientific literature, Polish civil society has been portrayed as weak and passive. This volume offers a much-needed corrective, challenging this characterization on both theoretical and empirical grounds and suggesting new ways of conceptualizing civil society to better account for events on the ground as well as global trends such as neoliberalism, migration, and the renewal of nationalist ideologies. Focusing on forms of collective action that researchers have tended to overlook, the studies gathered here show how public discourse legitimizes certain claims and political actions as "true" civil society, while others are too often dismissed. Taken together, they critique a model of civil society that is 'made from above'.




11 Effective Writing for Sociology: A Guide for Researchers and Students/ Kail, Ben-Routledge, New York, 2023; 150p.

Writing well is an essential skill for sociologists, but few books help students learn to write well. Designed to help students produce a manuscript that is clear, concise, and compelling, Effective Writing for Sociology demonstrates and deconstructs what makes effective writing and how best to communicate scholarly ideas. The first half of the book addresses the fundamentals of good writing writing clearly, conveying emphasis, writing concisely, and crafting effective paragraphs. The second half then looks to the three most important sections of a research report framing an introduction, reporting results, and discussing findings. Each chapter of the book describes strategies for effective writing, illustrated with multiple examples and providing exercises where students can try their hand at implementing these strategies. The Epilogue provides tips on choosing a title as well as writing an abstract and method section; it also includes suggestions on how to master the tips described in the lessons.





Emotions in Late Modernity is an international collection that explores how the individualized, reflexive nature of the late modern era has transformed our emotional experiences and expressions. Divided into four thematic sections, the volume highlights the growing complexity of emotions in contemporary life by challenging conventional binaries such as emotional rational positive negative emotional valence, and the disciplinary divides among sociology, philosophy, and psychologyparticularly concerning emotion, morality, gender, love, and loneliness. It investigates the tension between collective and individualized emotions by examining emotional sharing, personal responsibility for anger in legal contexts, and the dynamics of emotional energy in educational settings. The book further contrasts historical modes of emotional mediation through texts and bodies with today's digital forms, such as in classrooms, public protests, films, and documentaries. Finally, it delves into the micro and macro management of emotions, addressing issues like the politics of fear related to asylum seekers and religion, and the collective emotional commitment to addressing climate change. As the first volume to systematically analyze the shifting nature of emotional life in the late modern period, this collection is a valuable resource for students and researchers in sociology of emotions, cultural studies, political science, and psychology.



13 Exploring Grief. Towards a Sociology of Sorrow/ Jacobsen, Michael Hviid-Routledge, New York, 2020; 244p. 54290

As modern society's routine sequestration of death and grief is increasingly replaced by late-modern society's growing concern with existential issues and emotionality, this book explores grief as a social emotion, bringing together contributions from scholars across the social sciences and humanities to examine its social and cultural aspects. Thematically organised in order to consider the historical changes in our understanding of grief, literary treatments of grief, contemporary forms of grief and grief as a perspective from which to engage in critique of society, it provides insights into the sociality of grief and will appeal to scholars of sociology, social theory and cultural studies with interests in the emotions and social pathologies.



14 Fatherhood: Roles, Responsibilities & Rewards (Family Issues in the 21st Century) / Leyton, Chelsea H- Nova Science Publishers, New York, 2011; 177p.

In an effort to understand the role that fathers play in the development of their children, research literature examines the amount of time that fathers spend interacting with, being available to, and being responsible for their children. A model examining these different types of parental involvement is described herein. Also discussed in this book is the effect that paternal depression may have on family relationships and offspring functioning and an examination of the co-parental relationship and the impact this foundation has on the transition to fatherhood. This book also explores prospective fathers involvement in the decision making process with regard to foetal screening: fatherhood in Chinese culture, and a look at fathers and homelessness.




15 Gender, Class and Power/ Tricia, Dawson- Palgrave Macmillan, London, 2018; 267p. 54292


16 Human Sexuality. Biological, Psychological, and Cultural Perspectives/ Bolin, Anne-Routledge, New York, 2021; 596p. 54293


17 Introductory Readings in Anthropology/ Callan, Hilary- Manohar Publishers, New Delhi, 1999; 458p.


18 Language Production/ Hartsuiker, Robert J.- Routledge, New york, 2023; 340p. 54295

19 Linguistic Survey of India 11 Vols. In 20 Parts/ Grierson, George A-Routledge, New York, 2023; 9823p. 54221-54229

The Linguistic Survey of India is a comprehensive survey of the Language of British India, describing 364 languages and dialects. At the Oriental Congress held at Vienna, it was noted that the number of Indian Languages was unknown with estimates varying from twenty to 250. A resolution was passed urging the government to undertake a deliberate systematic survey of the languages of India. In 1900 the author moved to England for convenience of consulting European libraries and Scholars. By 1903 most of the data had come in. On Tibetan Languages the author worked with Sten Kono. On 8 may 1928 the completion of the Linguistic Survey of India was celebrated at the Criterion Restaurant by the Royal Asiatic Society of Great Britain and Ireland with Lord Birkenhead. It is a monumental publication describing every known Languages and dialects of South Asian subcontinent. ABOUT THE AUTHOR:—Sir George Abraham Grierson, OM, KCIE (1851-1941) was an Irish administrator and Linguist in India.



He won Prizes for studies in Sanskrit and Hindustani, become magistrate and collector at Patna. He proposed a formal Linguistic survey at the Oriental Congress in 1886 at Vienna. The congress recommended the idea to the British Government and he was appointed Superintendent of the newly created Linguistic Survey of India in 1898. He continued the work until 1928 and published the findings of the Linguistic Survey in a series that consisted of volumes and parts. Grierson received an honorary Doctorate (D. Litt) from the University of Dublin in June 1902. In 1928 he was appointed to the Order of Merit (OM) and was a Sir William Jones Gold medallist in 1929. He was appointed CIE in 1894 and KCIE in 1912.

20 Meaning Semantics, Pragmatics, Cognition Birner, Betty J.- Routledge, New york, 2023; 322p. 54296

Meaning addresses the fundamental question of human language interaction what it is to mean, and how we communicate our meanings to others. Experienced textbook writer and eminent researcher J. Betty Birner gives balanced coverage to semantics and pragmatics, emphasizing interactions between the two, and discusses other fields of language study such as syntax, neurology, philosophy of language, and artificial intelligence in terms of their interfaces with linguistic meaning.

This volume brings together an international team of authors to investigate a wide range of issues concerning the fundamental role of media technologies in shaping contemporary emotional life. Chapters explore key aspects of the mediatisation of emotional life, feelings and interpersonal relations: love, intimacy, loneliness, friendship, family relations, erotic, sexual and romantic experiences. The authors explain the key aspects of strong user-media relationships and human relationships based on media use and investigate problems such as the formation of identity based on social media, the role of communication applications and the effects of mobile and locative media on our relationships, as well as artificial intelligence, on our perception of our emotions. With a focus on new media, the book also draws on the scope of traditional media that express and shape emotions, taking into account the classic approaches to emotionality of messages from the perspective of film creators and recipients. This cuttingedge collection will be of interest to scholars and students of media and communication studies, especially digital media and new technologies, psychology, pedagogy, sociology of everyday life and cultural studies.

22 Medieval Indian Literature: An Anthology/ Paniker, K Ayyappa- Manohar, New Delhi, 2022; 1006p.

This volume, the first of three, has two parts: Surveys of all the languages and Selections from three languages - Assamese, Bengali and Dogri. The surveys present an objective assessment of the different literary trends and of the beginnings of the medieval period and comment on the origin of some of the Indian languages which came into being in this period. Besides laying stress on the contributions of individual authors and their historical significance, they also feature the intrinsic literary merits of the major works written during this period.




23 Messy Europe: Crisis, Race, and Nation-state in a Postcolonial World Loftsdöttir, Kristin-Manohar, New Delhi, 2020; 254p. 54232

Using the economic crisis as a starting point, Messy Europe offers a critical new look at the issues of race, gender, and national understandings of self and other in contemporary Europe. It highlights and challenges historical associations of Europe with whiteness and modern civilization, and asks how these associations are re-envisioned, re-inscribed, or contested in an era characterized by crises of different kinds. This important collection provides a nuanced exploration of how racialized identities in various European regions are played out in the crisis context, and asks what work "crisis talk" does, considering how it motivates public feelings and shapes bodies, boundaries and communities.



24 Migration Without Borders: Essays on the Free Movement of People/ Pécoud, Antoine-Manohar, New Delhi, 2023; x, 308p. 54233

International migration is high on the public and political agenda of many countries, as the movement of people raises concerns while often eliuding states' attempts at regulation. In this context, the 'Migration Without Borders' scenario challenges conventional views on the need to control and restrict migration flows and brings a fresh perspective to contemporary debates. This book explores the analytical issues raised by 'open borders', in terms of ethics, human rights, economic development, politics, social cohesion and welfare, and provides in-depth empirical investigations of how free movement is addressed and governed in Europe, Africa, the Americas and Asia. By introducing and discussing the possibility of a right to mobility, it calls for an opening, not only of national borders, but also of the eyes and minds of all those interested in the future of international migration in a globalising world.




25 Mind: The Mystery Within/ Sachdeva, Ashok K- Overseas Press, New Delhi, 2022; 398p.

Mind is not a gross thing, visible and tangible. Its existence is nowhere seen. Its magnitude cannot be measured. It does not require a space to exist. Mind and matter are two aspects as subject and object of one and the same all-full Pure Spirit (Brahman), who is neither and yet includes both. Mind precedes matter. This is Vedantic theory. Focusing on the period between the Suez Crisis of 1956 and the Falkland War but offering connections to the moment of Brexit, it argues that the "lost continent" of existential, satirical, simulated, and abstractly traumatic war stories is as central to understanding Britain's martial history as the mainstream inheritance. The book features case studies that stress the contribution of exiled or expatriate directors and outsider sensibilities, with particular emphasis on Peter Watkins, Joseph Losey, and Richard Lester. At the same time, it demonstrates concerns and stylistic emphases that continue to the present in television series and films by directors such as Lone Scherfig and Christopher Nolan. Encompassing everything from features to government information films, the book explores related trends in the British film



industry, popular culture, and film criticism, while offering a sense of how these contexts contribute to historical memory.

A critical mapping of the multiplicities of Finnish artist and technology pioneer Erkki Kurenniemi-composer of electronic music, experimental filmmaker, inventor, collector, futurologist. Over the past forty years, Finnish artist and technology pioneer Erkki Kurenniemi (b. 1941) has been a composer of electronic music, experimental filmmaker, computer animator, roboticist, inventor, and futurologist. Kurenniemi is a hybrid—a scientist-humanist-artist. Relatively unknown outside Nordic countries until his 2012 Documenta 13 exhibition, "In 2048," Kurenniemi may at last be achieving international recognition. This book offers an excavation, a critical mapping, and an elaboration of Kurenniemi's multiplicaties. The contributors describe Kurenniemi's enthusiastic, and rather obsessive, recording of everyday life and how this archiving was part of his process; his exploratory artistic practice, with productive failure an inherent part of his method; his relationship to scientific and technological developments in media culture; and his work in electronic and digital music, including his development of automated composition systems and his "video-organ," DIMI-O. A "Visual Archive," a section of interviews with the artist, and a selection of his original writings (translated and published for the first time) further document Kurenniemi's achievements. But the book is not just about one artist in his time; it is about emerging media arts, interfaces, and archival fever in creative practices, read through the lens of Kurenniemi.
