
NOTICE INVITING QUOTATIONS

Sealed quotations under Limited Tender Enquiry are invited on or before 21.01.2026 up to 05:00 pm from the scrap dealers / kabari walas / individuals for auction of condemned **Equipment, Electrical, Electronic Items Computer peripherals, scrap Metals, building materials, Furnitures etc.** in the Indian Council of Social Science Research under the Ministry of Education. The prescribed quotation form can be downloaded from ICSSR website www.icssr.org.

INSTRUCTION AND TERMS & CONDITIONS: -

1. The condemned **items** are offered for disposal on "AS IS WHERE IS BASIS".
2. The bidder may inspect the said condemned items from 01.01.2026 between 11:00 am to 4:00 pm. No complaint whatsoever will be entertained after the bid is submitted or after the condemned items are lifted from the premises. No request for inspection after submissions of bid will be accepted.
3. The sealed bids superscribed "bids for the sale of **condemned items** on an envelope, will be received latest by 21.01.2026 upto 1:00 pm. The same will be opened on 22.01.2026 at 3:00 pm in the presence of bidders, if any. The bids should be addressed to the Administrative Officer, ICSSR, Aruna Asaf Ali Marg, New Delhi - 110067.
4. In the event of acceptance of bids, the successful bidder will be required to deposit full amount via DD in favour of ICSSR payable at New Delhi. Payment may also be made through online transfer.
5. The materials will be allowed to be lifted between 10:00 AM to 5PM on any working days, No Picking, choosing or sorting will be allowed in the premises for disposal lots.
6. The condemned items will be delivered only after the receipt of full payment and has to be lifted within two days of completion of deal.
7. Once the release order is issued, this office will not be responsible either for safe custody or for any loss or damage to the subject Items.
8. The highest bid once accepted is not transferable to anyone. In case the bidder is a company the person appearing for the company should have the authorization letter issued from a competent authority of the company.
9. Quotations received after the prescribed date and time will not be considered under any circumstances. Overwriting must be avoided; otherwise, such defective quotation shall be summarily rejected.
10. The quotation should be submitted alongwith the security deposit of Rs. 10,000/- in the form of DD in favour of ICSSR, New Delhi or through online transfer in the bank account of ICSSR. MSME firm shall submit bid security declaration certificate along with quotations.
11. The highest bidder will deposit the balance amount either by Demand Draft favouring ICSSR, New Delhi or through online transfer within two days of completion of deal, failing which security amount will be forfeited.
