NOTIFICATION

ICSSR has decided to adopt Expenditure, Advance and Transfer (EAT) Module on the direction of Ministries of Finance and Human Resource Development, Government of India to ensure complete tracking of funds released and expenditure upto the last mile implementing agency.

All the implementing agencies of ICSSR- IMPRESS Scheme, will mandatorily use EAT Module with immediate effect failing which no further funds will be released to the agencies.

It is to take immediate actions on the following issues:

1. Implementation of EAT module in Universities/ Institutions/ Colleges funded by ICSSR- IMPRESS scheme be ensured w.e.f. FY 2019-20.
2. Bank Account(s) registered under PFMS for ICSSR-IMPRESS scheme (3615) **will not be registered** for any other funding agency. This Account(s) shall exclusively be used for ICSSR-IMPRESS scheme only, failing which Council will not release any further grant to the beneficiary Institutions.
3. Bank Account must be in the full name of the Institution, for eg. **Jawaharlal Nehru University (ICSSR-IMPRESS 3615)**.
4. Implementing agencies who are already registered on PFMS need to add the Scheme Code 3615 and for funding agency, select **ICSSR** as funding agency (not Central Govt or State Govt.) and inform us on mail id given below along with mandate form attached.
